The new development, slated for completion in 2019, will consist of commercial and retail space as well as three residential towers and will re-define the Burnaby neighbourhood of Edmonds.

We’re proud that this expansion into Kings Crossing will give us the chance to deepen our commitment to Burnaby by giving us the space we need to grow and thrive for many years to come,” says Lewis Bubl , President and Chairman of G&F Financial Group’s Board of Directors.

By bringing together a number of G&F operational departments under one roof, G&F looks forward to creating more opportunities for the collaborative synergy that is a powerful differentiator for the credit union.
